FLUENCE PRIVACY POLICY

Fluence DAO ("we," "us," or "our") is committed to protecting your privacy. This Privacy Policy explains how we collect, use, disclose, and safeguard your information when you access or use our website https://fluence.network (the "Site"), our hosting services provided via the Platform, and any related services (collectively, the "Services").
